- Resource origin
- Social aspects during dismantling and further processing

### **DE-UZ 208: Disposable diapers**

#### Scope:

diapers designed for use in infants, children, adolescents or adults; examples: panty nappies, diaper briefs, swimming nappies and pants.

#### Criteria:

- 100% of the wood used for pulp production comes from sustainable forestry
- strict limit values for process parameters in pulp production, e.g. waste water emissions and exhaust air, energy and bleach consumption
- extensive exclusion of hazardous substances, such as carcinogenic substances, halogen-containing polymers, heavy metals, acrylamide and natural latex in the plastics used, optical brighteners, additives such as lotions, mineral oil components, fragrances, odour binders
- avoidance of substances harmful to health and the environment, e.g. through strict regulation of residual monomers, water-soluble extracts, polyurethane and elastane, polyamides and silicones in the plastics used, strict regulation of adhesives; minimization of dyeing and printing
- high usability and quality
- high demands on the sales packaging






#### Procurement law below the EU threshold




# Circular Economy ACT (KRWG), the Climate Change Act (KSG) and the General Administrative Regulation on the Procurement of Energy-Efficient Services:

- **oblige** public purchasers to check whether environmentally friendly procurement options exist.

#### The new rules in the KrWG and KSG

- even **oblige** public procurement bodies to make the most environmentally friendly variant the subject of the contract, so that the procurement of other variants is no longer permissible.

## **Procurement statistics regulation (VergStatVO)**

- Start at 1.10.2020
- For the first time, collection of individual data on the public procurement procedures carried out in Germany (federal, state and local authorities),
- Valid for: Procurement processes with order values above the EU threshold values and with order values of more than 25,000 euros below the EU threshold values
- Results are made available to the general public via the GENESIS online database (<a href="https://www-genesis.destatis.de/genesis/online">https://www-genesis.destatis.de/genesis/online</a>)
