

# Eco Mark Fee Provision

Japan Environment Association

Article 1 The provision shall define Eco Mark related fees.

Article 2 The fees shall be divided into the following three types:

- 1) Application Fee for Eco Mark Product Certification
- 2) Eco Mark Annual License Fees
- 3) Eco Mark Certificate Issuance Fees (This covers reissuance and additional issuance of a certificate.)

Article 3 The application fee for Eco Mark product certification, Eco Mark license fees, and Eco Mark certificate issuance fees shall be defined in the appendix and published.

Article 4 The application fee for Eco Mark product certification, Eco Mark license fees, and Eco Mark certificate issuance fees shall be reviewed as needed.

2 In light of the public interest of the Eco Mark program, the review of fees mentioned in the preceding paragraph shall be made, considering the number of Eco Mark utilizing contractors, transition of sales of Eco Mark products, number of certified products, review of the certification criteria, and other various factors.

40,000 yen

When multiple facilities are applied under No.509 “Retail facility” at one time, the application fee for the 4th and subsequent facilities will be 20,000 yen per facility (excluding consumption tax).
